Job Announcement Firefighter/AEMT – Career

The Mount Horeb Area Joint Fire Department (FDMH), located near Madison, WI is now accepting applications for two immediate openings for the position of Firefighter/AEMT. This process will also create a list to be used for hiring in 2024. Under the direction of the Fire Chief and following the chain of command, the Firefighter/AEMT will provide FDMH with various duties that may include response to emergency calls, data management and reporting, administrative support operations, facilities and apparatus maintenance, training, and fire inspections and prevention activities.

FDMH proudly protects 13,000 people living in an area of 137 square miles. In 2023 we responded to 1260 EMS calls and 584 fire calls. We operate out of one station that protects a primarily rural area. FDMH is a combination department consisting of career, part-time, intern, and volunteer members totaling 70 personnel. 911 EMS transports are provided at the Advanced EMT level, flexing to Paramedic. FDMH is proud to offer protection services to the Villages of Mount Horeb and Blue Mounds, and the Towns of Blue Mounds, Cross Plains, Perry, Primrose, Springdale, and Vermont.

Compensation and Benefits: Starting annual salary for this position as an AEMT is \$52,929.64 plus potential for overtime and paramedic incentives. This position is represented by IAFF Local 311 and a new contract is currently being bargained. Comprehensive benefits include health and dental insurance, income continuation, State of Wisconsin Retirement Service (protective), vacation, sick leave and paid holidays. Voluntary benefits are available such as life insurance, deferred compensation, accident insurance, vision insurance and access to an employee assistance program.

Required Qualifications: At the start of position, must have current Wisconsin, IFSAC or Pro Board certification as a Firefighter II. Wisconsin licensed or National Registered AEMT, with a preference toward Paramedic. Valid State of Wisconsin Driver's License. Driver/Operator within 12 months of employment. Fire Inspector and Aerial Operator within 18 months of employment. This position is subject to a residency requirement to establish and maintain residency within Dane County or contiguous counties within 18 months.
